Installed floorboards/panels are considered surface approved.

The product warranty does not cover any labour cost associated with replacement of damaged material covered by the warranty, unless national regulations pledge Alloc AS to do so.

Valid receipt of the installation must then be presented.

The product warranty does not cover damage to the product caused by:

- Installation errors or transport damage.
- Accidents, product misuse or product abuse, such as scratches, blows, cuts or damage caused by sand (i.e. lack of precautions according to "cleaning & use" described in fitting instructions) or other abrasive materials
- Traffic higher than the area of use.
- Improper maintenance.
- Flooding, standing water (water and detergents) or trapped water between the Alloc products and the subfloor.

In order for this warranty to be valid, legitimate documentation of purchase must be presented.

This warranty gives you as the end-consumer specific legal rights. You may have also other rights, which may vary from country to country.
